



Official Rules for the Enter to Win Prize Vacation of a Lifetime at Hendricks Creek Resort on Dale Hollow Lake! Prize package valued at \$2375.

Houseboat Adventure Trip Prize sponsored by Hendricks Creek Resort

1. Duration of contest. The contest runs from Friday, January 14th, 2022 through 4 pm, Sunday, January 23, 2022.
